1. Complete the application and description form and send it with a non-refundable registration fee of \$30 to be postmarked no later than Monday, March 22. *A returned check will disqualify your entry.*
2. Submit a maximum of five digital photos of your work. Please do not send actual product samples or prints. A photo of your booth display is highly recommended.
3. You may submit your photos on a CD or via email (artinthehighlands@loucol.com). Please number photos on CD or in email to correspond with their descriptions submitted on the enclosed form. Please include prices of your work.
4. All applications and descriptions must be submitted with photos. To access an electronic application, please visit www.loucol.com/artinthehighlands
5. CDs will not be returned without a stamped, self-addressed envelope.

Please note:

- Only works in the same medium selected by the jury may be displayed during *Art in the Highlands*.
- Items not accepted for jury are needlework from kits; works made from molds; culinary items; manufactured jewelry; and antiques or flea market items.
- Each artist must have his/her own display equipment, including a 10' x 10' white tent and is responsible for keeping his/her own booth free of clutter and trash.
- Kentucky law requires collection of a 6% sales tax on all sales made during *Art in the Highlands*.

Results will be mailed to you as soon as the jury selection has been made, no later than April 9, 2010. If you are invited to attend *Art in the Highlands* a 10 x 10 feet space will be reserved for you at a booth fee of \$300. The booth fee is non-refundable. Booth space is limited and the *Art in the Highlands* committee reserves the right to limit the number of artists in any medium, as well as total participants.

Non-compliance with any aspect of the jury process or any of the requirements outlined above may result in ineligibility for the 2010 *Art in the Highlands*, as well as future shows.
